*Final Record of Decision, Track 2, Bureau of Land Management Area B and Munitions Response Site 16, Former Fort Ord, California* (Administrative Record number: OE-0897) was signed on May 3, 2017. In accordance with the Fort Ord Federal Facility Agreement (FFA) the Army submitted a proposed schedule for the associated remedial design and remedial action work plans to U.S. Environmental Protection Agency (EPA) and California Department of Toxic Substances Control (DTSC).
