## **APPENDIX C**

### **U.C. SANTA CRUZ PARCEL - ASBESTOS SURVEY HISTORY**

The following table was prepared by DEI on behalf of Fort Ord and HLA for the purpose of preparing this EBS document. In January 1994, HLA provided DEI with a list of buildings within the U.C. Santa Cruz parcel defined by the Army and requested that DEI provide (in tabular format) the information shown in the table headings. DEI is performing asbestos surveys of buildings at Fort Ord independently of this EBS project.

The building list is based on building numbers gathered from Fort Ord base maps and interviews with Fort Ord personnel. Possible sources of error in the building list include:

- Structures with numbers on a map that either are not buildings (i.e., flagpoles, loading docks) or have been demolished - where possible, these have been identified on the table
- Structures that do not appear on available maps - where possible, such buildings have been identified by comparing the DEI asbestos survey summary with a building list; however, there may be structures within the parcel that are not on the base map and were not part of DEI's survey scope.
- Structures incorrectly numbered on a base map
- Margin of error in current definition of parcel boundaries


