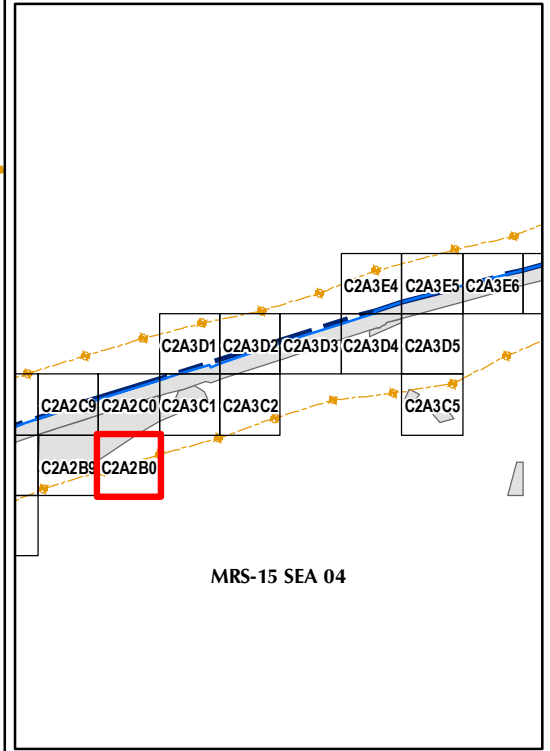

State Plane California IV, NAD 1983 (U.S. Survey Foot)

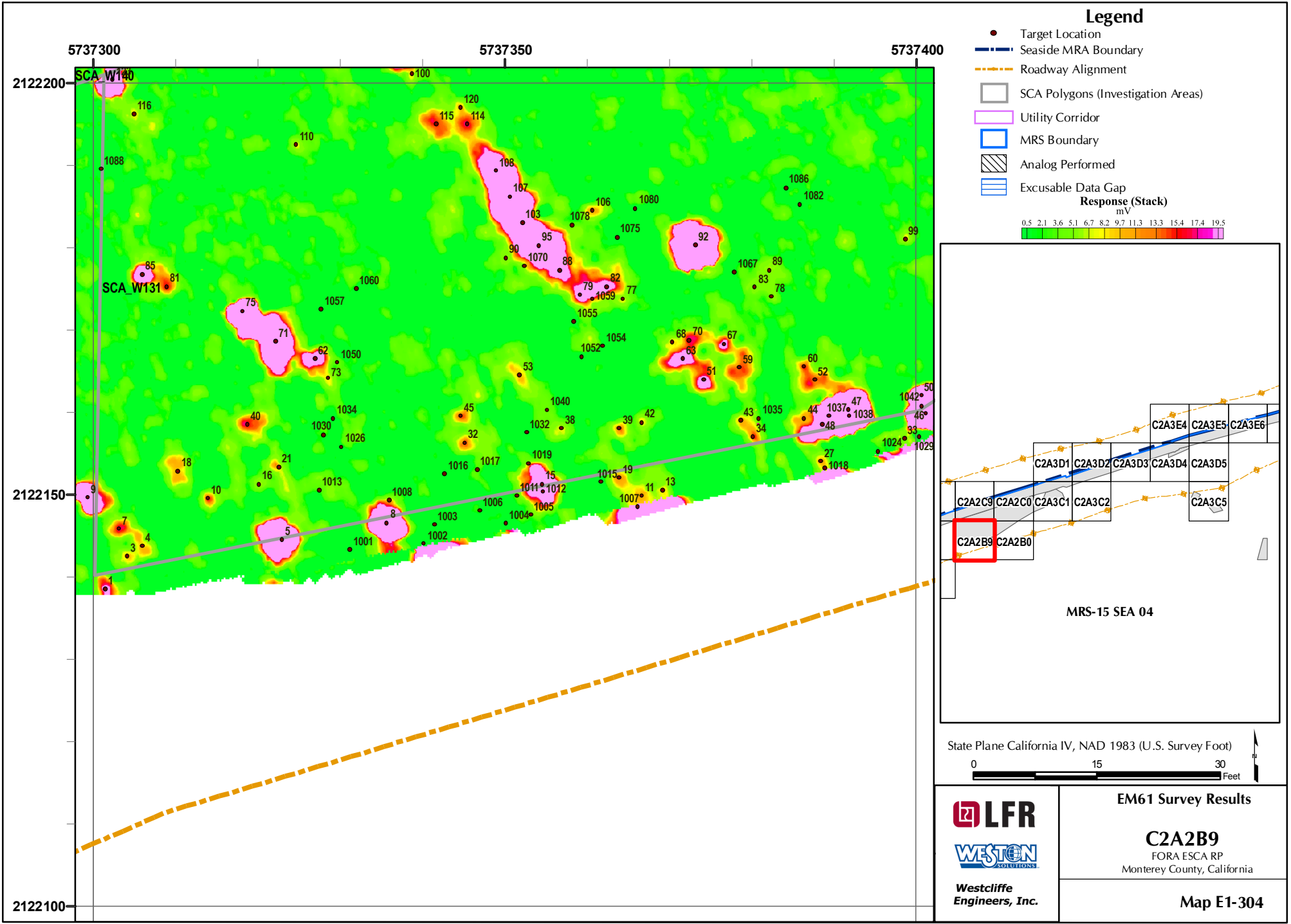
